Re: Puerto Rico Medicaid Program Provider Enrollment Portal – Wave 7 Training and Enrollment Dates

Dear Provider:

Receive a warm greeting on behalf of First Medical Health Plan, Inc. (FMHP).

Committed to maintain you informed about the communications issued by the Puerto Rico Department of Health, attached to this letter you will find the Informative Letter related to the Puerto Rico Medicaid Program Provider Enrollment Portal – Wave 7 Training and Enrollment Dates, issued on August 3, 2020.

Through this notice, the Puerto Rico Department of Health affirms that you must enroll in the Provider Enrollment Portal (PEP) of the Puerto Rico Medicaid Program (PRMP) to comply with the provisions of the Affordable Care Act of 2010 (ACA), which requires State Medicaid Agencies (SMA) to enroll their providers in the Medicaid Program. The seventh wave will begin in August 10, 2020.

To facilitate the provider registration process, PRMP will offer training through in-person sessions and online tools such as training modules and digital guidelines for reference. To participate, providers must register by creating a user in the Learning Management System (LMS) using the following link: https://lms-prmmis.myhcplatform.com/. The authorization code 5247 must be used to create the ID and password for this platform.

In addition, they also encourage all Wave 7 providers to visit the website https://www.medicaid.pr.gov/Home/ProviderPortalEnrollment/, which contains a direct link to the PEP beginning on August 5, 2020. Wave 7 of enrollment will be for the following providers: Audiologist, Certified Registered Nurse Anesthetist (CRNA), Chiropractor, Midwife, Nutritionist/Dietician, Occupational Therapist (OT), Optometrist, Physical Therapist (PT), Podiatrist, Psychologist, Social Worker, Speech Language Pathologist (SLP).

For specific details of the information provided by the Puerto Rico Department of Health, to learn about the Portal functions and the enrollment waves, we encourage you to read the attached notice carefully.

Re: Provider Enrollment Portal (PEP) – Wave 7 Training and Enrollment Dates

This letter reinforces important information regarding the requirement to enroll in the Puerto Rico Medicaid Program (PRMP) via the Provider Enrollment Portal (PEP). All providers that provide, bill for, order, prescribe, or refer services for Medicaid beneficiaries under the Puerto Rico Government Health Plan (Vital or Platino Medicare Advantage plans) are required to enroll. Important information, including dates for training and enrollment, is provided below.

As a reminder, the PRMP will implement the PEP to comply with the Affordable Care Act of 2010 (ACA), which requires State Medicaid Agencies (SMAs) to enroll providers in the Medicaid Program.

Wave Schedule

Providers will enroll in waves by their provider type. Provider Types listed in Wave 7 begin their enrollment on August 10, 2020 and will conclude in October 19, 2020. The provider must register in their corresponding wave.
